Terms and Conditions:

We suggest that you Slowly introduce the kitten to other pets: The new kitten should be isolated from other pets, especially cats, and slowly in a safe way introduced to other members of your household. It is always good to allow them a smaller area at first as a safe space but not someplace where they will not be involved with you and your household. This allows for a period of time in which you and your kitten may bond. The kitten will then be more secure when introduced to the larger household and other pets. Be sure you have plenty of litter boxes initially as kittens have short memories.

It is critical that you be available to spend time to bond with your new kitten / kittens in the first few days after you receive them. They will be stressed after leaving home and family. It's like bringing home a new baby... Have the kitten examined by a certified Veterinarian within 5 Days. Our kittens are guaranteed to be of sound health, at the time of adoption. We strongly urge you to have your new kitten or kittens examined by a certified veterinarian as soon as possible. If the kitten is found to be ill, in the first 5 days (five Days), it must be reported

immediately, with confirmation from a certified veterinarian. If the condition is treatable, Registered Bengals will reimburse for reasonable and customary veterinary medical charges. If the kitten is found to be medically deficient with an un-treatable or life-threatening condition steps will be taken to provide for the return of the kitten. Upon the return/demise of the ill kitten, a replacement kitten of equal value will be provided as soon as nature permits, hopefully within 6 months.

Our kittens are guaranteed against any congenital defects for two years from birth. Should the kitten die or become terminally ill during that time, as a result of a congenital defect, the kitten will be replaced with another of equal value as soon as nature permits, hopefully within 6 months. Replacement is dependent upon the return or demise of the kitten. This will be done ONLY with a certificate of necropsy and cause of death, in the event of death, or certification of specific congenital illness or defect.

Failure to provide your kitten with veterinary care will void this guarantee.

Guarantee does not cover costs associated with spaying or neutering, including undescended testes.

Breeding Rights. Unless noted as a Breeder above this kitten / Cat is <u>not</u> sold with breeding rights. If the Kitten / Cat was sold as a breeder and noted as such above, then Registered Bengals guarantees that it will be fertile and free of congenital defects for a period of two years from birth. If it is determined by a certified veterinarian that the kitten / cat is infertile or has a life-threatening congenital defect the kitten / cat will be replaced with another of equal value as soon as nature permits, hopefully within 6 months. Replacement is dependent upon the return of the kitten / cat.

Breeding. On occasion buyers purchase a kitten with the intention of having it solely as a pet but then determine that they would like to breed it. There is a difference in the price of a kitten sold for breeding purposes. You will not receive the kitten's registration papers until you Spay or Neuter the kitten. If you honestly change your mind and think you'd like to breed the kitten / cat, contact us and we can see if this kitten would be appropriate to start a breeding program with. You will have to pay the difference between the pet and breeder price (\$2,000 per Kitten). If you violate this provision Registered Bengals reserves the right to retrieve the kitten / Cat and to assess a penalty equal to the original purchase price of the kitten and to recover any and all legal costs associated with this process.

Registration. Unless sold as a breeder we will be holding your registration paperwork until the kitten has been neutered or spayed. This MUST be completed within 4 to 5 months of your purchase and we suggest you do so BEFORE your new kitten reaches sexual maturity. We will send your registration paperwork to you to register your new kitten or kittens when we receive confirmation in the form of a copy of the Veterinary bill for the procedure. If you violate this provision Registered Bengals reserves the right to retrieve the kitten / Cat and to assess a penalty equal to the original purchase price of the kitten and to recover any and all legal costs associated with this process. If you change your mind and choose to breed your kitten contact us and you can pay the difference in the Pet price and Breeder price which is currently \$2,000. Per kitten.

Provide proper vaccinations for the kitten on a schedule determined to be proper by a certified veterinarian. It is essential that your kitten be vaccinated and checked for parasites (internal and external) on a schedule prescribed by a certified veterinarian. You will be provided a medical record for the kitten along with other paperwork. Be sure to review the medical record with your veterinarian and get a recommendation for follow-up. Maintain the kitten as an indoor-only pet... A safe alternative is to give your kitten access to the outdoors but in a controlled environment. Create an enclosed outdoor area for your cat to play in or teach him / her to walk on a leash and harness. Either option will allow them access to the outdoors in a controlled, safe manner. After all, you have invested a great deal of time, emotion, and money in your new kitten - why take the risk of serious injury, disease, death, or loss to a dishonest person?

Provide a safe and healthy environment for this kitten. You can take a few simple steps that will go a long way toward keeping your pet healthy and happy. Pet proofing your home can lower the risk of a serious pet accident occurring. A pet owner needs to be aware of several potential dangers. Poisons in the home that can kill or seriously injure your pet include some kinds of houseplants, pesticides, and medications. Low electrical cords are extremely hazardous when chewed. A little prevention may be just enough to avoid a tragedy from happening in your home. Additionally kittens are very fast and it's easy for them to get underfoot and between your legs. We strongly encourage you to purchase pet medical insurance such as Trupanion or another insurance as a small accident can add up to large Veterinary bills very quickly.

Keep the kitten clean, well fed with nutritious food; Provide clean, fresh water; and provide the kitten with plenty of attention. Owning any animal means being responsible for providing appropriate and humane care. Provide the kitten with adequate food, water, and access to a hazard-free area for play and never cage except for travel, health, showing or similar reasons.

Never have any of the kitten's paws de-clawed. Declawing is a horribly painful and abusive surgical procedure that is without benefit to the cat. It is illegal in most countries and should be outlawed in the USA as well. Declawing is an irreversible surgical procedure performed by a veterinarian while the cat is under general anesthesia. Hospitalization for 1-2 days may be required. A cat's toe has three bones; the claw grows from the end of the last bone. In declawing, the veterinarian amputates the end section of the last bone, along with the claw. This removes the claw and prevents it from growing back. The toe is then sewn shut with absorbable sutures or closed with surgical skin glue, and each paw is bandaged snugly to control bleeding. *This provision will be strictly enforced!*

Provide immediate medical care if the cat/kitten shows signs of illness or distress. That cute little kitten stole your heart and now he's part of your family. You love him or her to death but remember -- you are responsible and taking care of your cat and it is a year-round duty. Work closely with your Veterinarian to schedule annual physical examinations. Your kitten can't tell you how it's feeling so you must familiarize yourself with its normal behavior. That way you will know when they are sick. Registered Bengals is NOT responsible for your veterinary expenses.

Never neglect or abuse this kitten / kittens. It is regrettable that this condition must be included, however, experience has shown that some people do not understand their responsibilities as a cat owner, and so we include it for the sole protection of the cat. Neglect shall include but is not limited to: being left alone without human companionship for periods in excess of 72 hours; lack of proper sanitary facilities; poor diet; poor health, and otherwise poor condition. Mistreatment shall include but is not limited to lack of proper food, lack of water and physical abuse and lack or appropriate medical attention when required.

If your kitten / Kittens are found to be neglected or abused by the Humane Society, SPCA, local police or animal rights organizations in your area, you immediately loose the ownership rights to the kitten / kittens and they become the property of Registered Bengals. We will make arrangements to retrieve them and if they were sold as breeders this applies to their kittens as well. We will make arrangements with the local authorities to retrieve them. There will be no reimbursement for this. Abuse or neglect of an animal is never ok or tolerated!

Never sell, lease, lend, give, or abandon the kitten to a shelter, pound, pet store, animal humane organization, veterinarian, researcher organization, or any similar organization, institution, or person. Registered Bengals kittens are placed in what, at the time, is believed to be a responsible, cat-loving, home. However, sometime events occur that make it impossible for the cat to remain in the home. It is required that you contact Registered Bengals for assistance in the relocation of the cat to another responsible, cat-loving home. Please note that failure to do this will be considered a breach of the terms and conditions of this contract and trigger the remedies specified.

Make provision for the care of the kitten in case you should die or otherwise become unable to care for the kitten. Pets usually have shorter lives than humans so it is natural that we give little thought to what would happen to our kitten should something happen to us. But what if you are the one who becomes ill or incapacitated, or who dies first? You should give this very careful thought and then talk with the person(s) that you wish to assume responsibility for the cat(s) should you no longer be able to care for them. Upon their agreement you should then inform other members of your family and friends and put it in writing.

At no time will Registered Bengals be responsible for your Veterinary Costs. Registered Bengals makes every effort to ensure that your new kitten / cat is healthy when it is sold to you, it is your responsibility to have it vet checked within 5 Days of your purchase of the kitten. These costs and any other costs associated with the care of your kitten are your sole responsibility and not the responsibility of Registered Bengals. If it is determined during your 5Day veterinary visit that there are issues with the kitten that cannot easily be treated Registered Bengals will replace the kitten with another of equal value as soon as nature permits, hopefully within 6 months. Replacement is dependent upon the return of the kitten / cat.

Return Policy:

We care about each and every one of our kittens, so we have implemented a return policy. After purchasing a kitten from us, if at any time you can no longer keep your kitten you must contact us and return the kitten/adult cat. Understand that WE WILL NOT refund your purchase price. We will screen prospective new homes, if an adoption fee is obtained we will possibly refund some of that amount to you depending upon each individual situation. If you have a person who is wanting your kitten/cat, they must first complete our application process and be approved before obtaining them. We do reserve the right to refuse a home that we deem to be unfit for ownership.

Abide by contract terms as stated herein. If at any time you are determined to be in breach of any of the terms and conditions stated herein, the Seller reserves the legal right to remove the animal from the premises and the buyer will surrender the cat / kitten alive, any and all progeny alive together with appropriate papers to the Seller unconditionally and without compensation or refund and pay the seller a non-punitive sum of five thousand dollars (\$5,000) to defray costs of material, time and talent involved in the recovery.
